Anti-Drugs Policy

Adopted by the governing body: 18th November 2021

To be reviewed every two years

Review date: 17th November 2023

Introduction:

This policy sets out the position of the Academy on drugs and drug education in a local and national context.

It should be read in conjunction with the Academy's behaviour policy, medical treatment policy, no smoking policy and health and safety policy.

It is written following guidance from the DfE and ACPO drug advice for schools document (September 2012) and the DfE Searching, screening and confiscation advice document (January 2018)

Schools have an important role to play in tackling drug misuse in England, by providing education and pastoral support to all pupils and identifying those vulnerable to drug misuse, so that they may receive extra help and be referred to other services.

The policy applies to all staff, parents/carers, pupils, apprentices, governors and agencies working with the school and in the boundaries of the school grounds.

Definition:

Drugs are substances that may be medicinal, narcotic, hallucinogenic or stimulants. Their misuse or addiction to them are likely to cause harm. This document defines drugs as including alcohol, tobacco and illegal substances, as well as medicines and volatile substances.

Aims:

- Pupils will receive education regarding the misuse of drugs and alcohol through the curriculum such as science and social studies.
- External advice is also provided for pupils via workshops on collapsed MAD days throughout the key stages.
- To ensure that pupils understand the particular significance of certain drugs. staff will seek support where necessary in dealing with issues relating to the misuse of drugs and other substances. This might be through external agencies or the police.
- Parents and carers should understand that the misuse of drugs and other substances will not be tolerated by the school and they have a part to play in ensuring that their children are not putting themselves or others at risk.
- All persons connected with the Academy must understand which substances are covered by the Drugs Policy.

Substances considered as drugs

Drugs may be both legal and illegal substances. The Academy regards the following as drugs in accordance with government recommendations:

Volatile (sniffable) substances (e.g. petrol, alkyl nitrates, aerosols, butane, nitrous oxide)

Over-the-counter medicines (e.g. paracetamol, cough medicines)

Prescription medicines (e.g. tranquillisers, amphetamines, anabolic steroids) Alcohol Tobacco/Vapes

Other legal drugs (e.g. caffeine)

Psychoactive substances

Illegal drugs (e.g. cannabis, heroin, LSD, ecstasy)

Use of medicines on Academy premises

Any pupil needing to bring medication into the Academy should have written guidance from a parent / carer. All medication should be clearly named and any unused medication must then be collected by a parent / carer. The managing and administering of medicines are tasks undertaken voluntarily by Academy staff.

Any pupil with a long term medical need will be fully supported by the Academy. Full details should be forwarded to relevant Academy staff.

Any pupil capable of administering his or her own medication may, with written parental consent, do so. Carrying personal medication could be in the pupil's interests where swift action is necessary as in the case of asthma sufferers, diabetics or pupils with anaphylaxis.

Academy staff may not 'prescribe' any form of medication, eg. paracetamol, for pupils suffering from migraines or similar conditions. Any pupil wishing to take some form of pain relief should have written consent from a parent / carer, as described above.

Responding to misuse of drugs on Academy premises

All members of staff will be aware of the risk factors that may lead to the misuse of drugs and should report any concerns to a member of the SMT or teacher responsible for safeguarding.

These would include:

- misuse of any substances at an early age;
- problems at school;
- low expectation;
- low achievement;
- truancy or anti-social behaviour;
- family problems / influences;
- lack of parental support;
- family alcoholism or use of drugs;
- peer influences;

- isolation from peers;
- friends who use drugs;
- inability or unwillingness to resist peer pressure.

The Academy takes a serious view on the use and supply of drugs. Where a pupil is suspected or is known to have taken or supplied drugs the Academy disciplinary procedures will be applied. The individual circumstances of pupils will be considered when applying disciplinary measures. **Illegal and unauthorised drugs are never allowed on Academy property and immediate action will be taken.**

Following any incident of drug misuse, the Academy may decide to seek advice / assistance from outside agencies. These include:

School health services
Police Liaison Officer
Social services

Any decision taken by the Academy to involve specialist parties would be solely for the rehabilitation of the pupil.

Where drug misuse has been identified support will be offered to pupils / families through Addaction or other external agencies.

6	Intoxication	Pupil to be escorted to medical room and accompanied at all times. Medical assistance to be sought if necessary. Inform SMT and parents/guardians. Complete incident report.	Academy sanctions to be imposed if considered appropriate. Inform parents/guardians

Working with the Media:

Advice will be sought from the University of Lincoln Press Office on how any media enquiries about issues relating to drugs will be handled.

No information concerning particular individuals, whether pupils or staff, should ever be released, if there is the possibility that it could incriminate these people.

Searching and Confiscation:

If the school has reasonable grounds to suspect a pupil of being in possession of any banned item (including all the drugs listed in this policy) the pupil can be searched without pupil or parental consent.

The search will be conducted by the head teacher or a member of school staff authorised to do so by the head teacher.

The search will be conducted by a member of staff of the same sex as the pupil with another staff member present (unless there is believed to be a risk of serious harm if the search is not completed immediately)

During a search pupils may be asked to remove outer clothing (coats, blazers, jumpers, hats, gloves, scarves). Lockers and bags will be searched.

Staff can use appropriate force to search for prohibited items such as alcohol, tobacco, cigarette papers and illegal drugs.

Staff can use their discretion to confiscate, retain or destroy banned items found in the possession of pupils.

The school has a legal duty to deliver any controlled drugs, or substances suspected to be controlled drugs, to the police for disposal.
